YOUR RIGHTS
WHEN INJURED

What to do when you've been injured in an Auto Accident?

- Take pictures of the accident scene and anything that may possibly be relevant. Gather the name, address, license number and phone number of all witnesses.
- Get insurance information, drivers license, phone number and registration from the other driver.
- File a claim with your insurance company as soon as possible, also call the other drivers insurance company to make sure they have an open claim.
- Take care of your injuries and seek the medical care necessary. Documenting everything, including prescriptions, treatments, MRI and CT scans, and costs of care.
- Take pictures of wounds, bandages, bruises, and any other evidence of injury.
- Keep a journal of all medical treatment, including physical, mental or emotional injuries.



Important Things To Remember.

- Do not speak to insurance adjusters or give any statements (other than to the police) until you talk to a lawyer.
- Do not sign any liens or release of information without talking to a lawyer.
- If injured due to the fault of another, you are entitled to compensation for your injuries and expenses.
